SOCCER

Mr. Ralph Lunn, President and Mr. Dave Grantham, Fundraising Coordinator for Castlegar Minor Soccer attended the meeting to thank Council for their support of minor soccer over the years as well as to update Council on soccer in Castlegar.

Mr. Lunn and Mr. Grantham advised that:

- over 450 kids ages 4 18 play soccer in Castlegar with over 50 teams and over 75 coaches;
- 4 different fields are used: Millennium Park, Pass creek Park, Community Complex field and Stanley Humphries Secondary School;
- the Association's vision for soccer in Castlegar includes hosting a popular annual soccer tournament, expanding the playing season into the fall and an indoor facility for the winter season;
- potential field improvements identified by Castlegar Minor Soccer include field lights, permanent storage facilities and change room and permanent concession facilities.

Mr. Lunn thanked the City works crew for their work to improve and maintain the City's soccer fields. Mr. Lunn and Mr. Grantham suggested some areas where turf repair and other field improvements are required. The Millennium Park Master Plan, potential priorities for field lighting and the possibility of constructing a concession/storage area attached to the existing Millennium Park washroom building were discussed.

In closing, Mr. Lunn expressed the Association's desire to partner with the City of Castlegar, as well as business groups, to expand soccer in Castlegar.

Council thanked Mr. Lunn and Mr. Grantham for their presentation.

-MR. DAN SAHLSTROM AND MS. TRACI GOERTZEN -NEW VISION HOUSING Mr. Dan Sahlstrom, Chair of the Castlegar New Vision Housing Society attended the meeting to thank Council for their support to date, to provide an update on the activities of the Society and to introduce intern Ms. Traci Goertzen.

Mr. Sahlstrom advised that the work of the Society has increased thanks to the grant received through the Columbia Basin Trust Community Initiatives Funding Program. The Society is seeking additional funds required to undertake a \$30,000 Housing Need and Demand Study. The Society received \$10,000 in funding through the Teck Service Learning Internship Program and in conjunction with Selkirk College has hired Ms. Goertzen to work on this project. Ms. Goertzen has been working under the guidance of a consultant to research and gather data that the Society believes will be useful to the completion of the Housing Need and Demand Study.

Mr. Sahlstrom discussed the next steps which would include:

- identifying potential parcels of land that would be suitable for housing development in order to received funding from CMHC;
- if CMHC funding is secured, following up with the Columbia Basin Trust for matching funding; and
- building support in order to ensure that the community is included and involved in the initiative.

Ms. Goertzen provided information to Council on the housing projects that were undertaken in Nelson, Salmo, Revelstoke, Fernie and Trail once a Housing Need and Demand Study was completed for each of these communities. Ms. Goertzen also provided statistics regarding affordable housing that she has gathered during her research.

Council thanked Mr. Sahlstrom and Ms. Goertzen for their presentation.
