BYLAW 652

A bylaw to close a portion of a public highway.

WHEREAS Section 578(1)(b) of the Municipal Act provides that Council may by bylaw stop up and close to traffic a highway or portion of it;

AND WHEREAS it is deemed expedient and in the public interest to stop up and close to traffic a portion of a public highway;

NOW THEREFORE the Council of the City of Castlegar, in open meeting assembled, enacts as follows:

1. This bylaw may be cited as "Highway Closure Bylaw 652".
2. That a portion of the public highway lying between Lot A, District Lot 4598, Kootenay District, Plan NEP20158 and a portion of Lots 14, 15 and 16, Kootenay District, Plan 1520, District Lot 4598, shown shaded in heavy black in Schedule "A", which is attached to and forms a part of this bylaw, is hereby closed and stopped up to traffic of all kinds.
3. This bylaw shall be advertised in the Castlegar Sun prior to the adoption.
4. This bylaw shall come into full force and effect upon final adoption.



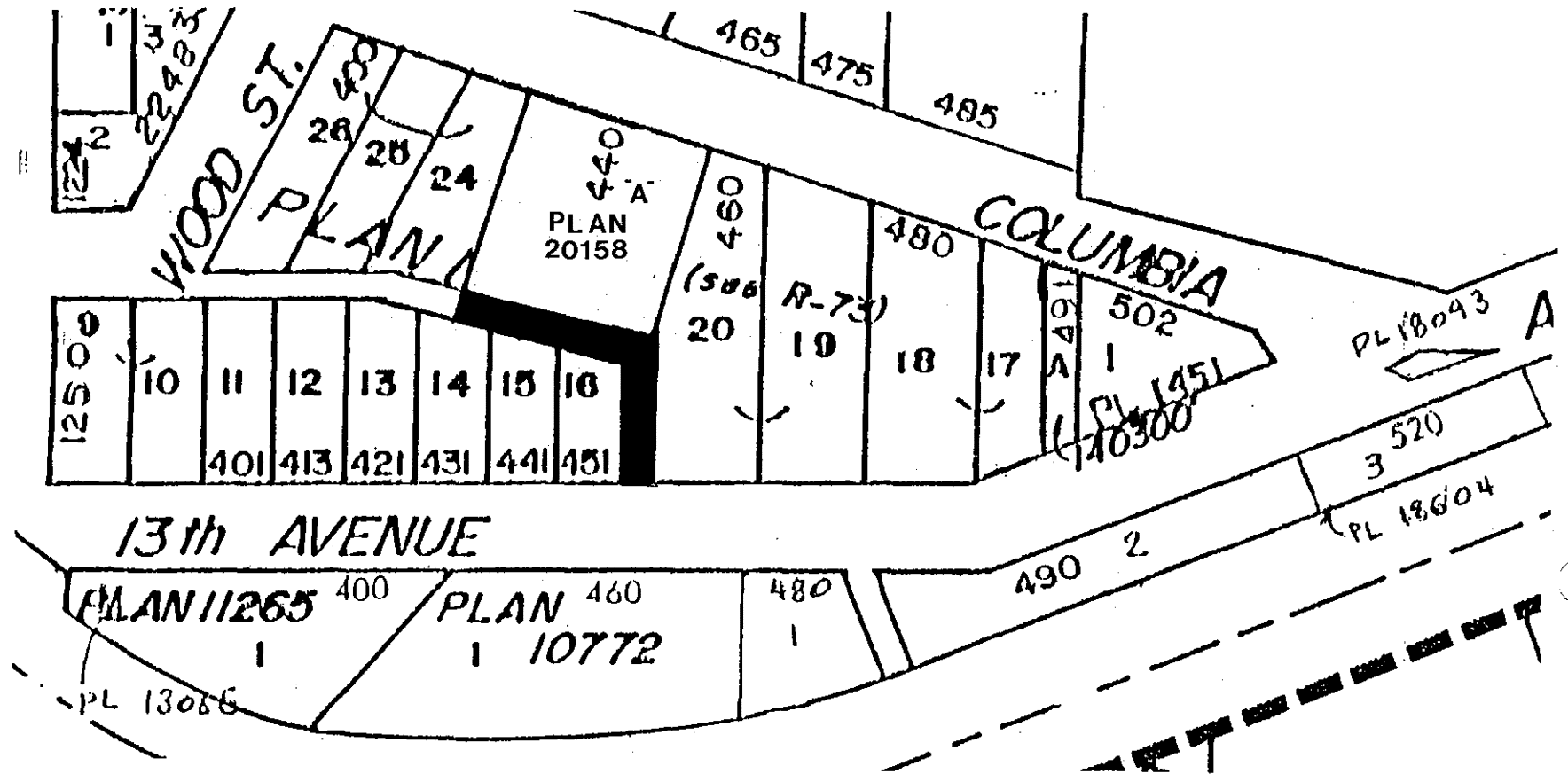
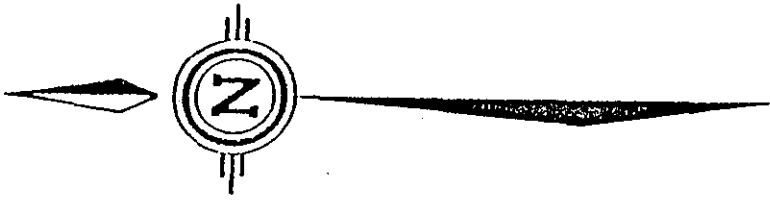
